The entrance hallway gives access to two large reception rooms, study and the open plan kitchen/breakfast room with separate utility and WC. To the first floor a large landing gives access to three bedrooms, two with en-suite shower rooms. To the uppermost floor there are a further three bedrooms, bathroom and boiler room. To the rear, there is also private lawned garden within the courtyard accessed from the kitchen/breakfast room. The property also comes with four allocated parking spaced to the front.


