Striking in design, the home combines brick, render and art stone with modern grey windows and bi-folding doors opening to a private, landscaped garden. The current owners have enhanced the property with professional landscaping and a veranda, creating a superb year-round entertaining space.

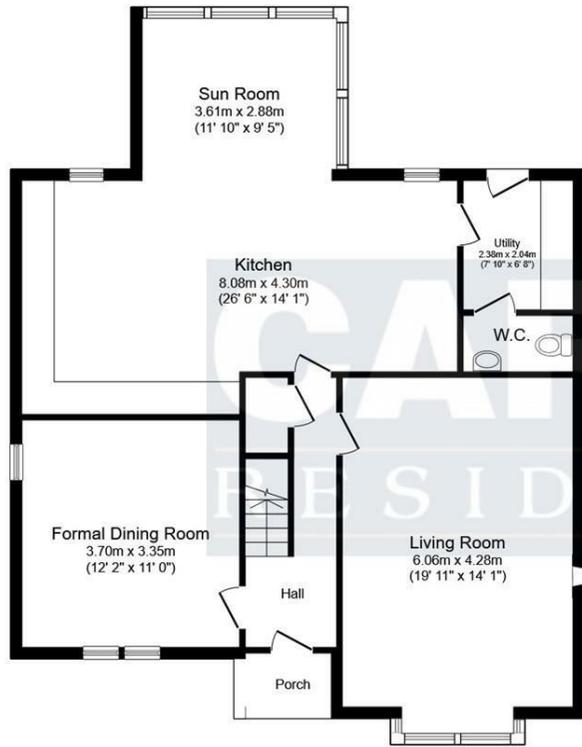
