SITUATION/LOCATION

The property fronts Newgate Street adjacent to Bishop Auckland Market Place and the Newgate Shopping Centre in the heart of Bishop Auckland town centre. Occupiers in the vicinity include The Works, Card Factory, Queensway Dental and Santander amongst a diverse variety of other established businesses. Bishop Auckland is a popular Market Town presently undergoing considerable regeneration around the Castle/ Market Place through the Auckland Trust. Bishop Auckland lies approximately 11 miles south of Durham, 12 miles north of Darlington and 14 miles east of Barnard Castle with convenient transport links across the region.

DESCRIPTION

Three storey retail premises of traditional construction held under pitched roof with flat section to rear.

The property incorporates glazed window frontage to Newgate Street comprising an open plan and versatile sales area across the ground floor (split level) with rear stores and strong room. The main sales area incorporates a suspended ceiling with integrated lighting, service counters and wood effect flooring.

The first floor comprises ancillary office/ staff accommodation with wcs. There is archive storage across the second floor.
